## Important Points to be noted in respect of IIA Chapter Election 2023-2025

- 1. Nominee for the post of the OFFICE BEARERS/ EXECUTIVE COMMITTEE MEMBERS shall be Fellow/Associate Members of IIA.
- 2. Nominees for the post of Office Bearers shall have served as Member of the Executive Committee of the Chapter at least for one full term of two years. (Attach Self Attested Copy of Proof)
- 3. A Self attested scanned copy of the Govt. issued Photo ID of the nominee shall be attached along with the Nomination Form.
- 4. Office Bearers shall not hold office for the same post for more than two consecutive terms.
- Candidate, Proposer, Seconder shall have paid their subscription up to the year of 2023-2025 by 22<sup>nd</sup> May, 2023.
- 6. A member can contest for ONE POST only. If nominations from candidates are received for more than one post and not withdrawn for other posts by the due date, nomination/s of lower post/s will be cancelled and nomination for higher post shall be retained.
- 7. A co-opted member is eligible for election as an Office Bearer only if he/she has been co-opted in the FIRST executive committee meeting of the concerned Chapter, and continued to serve for the full term of the concerned Executive committee.
