## Important Points to be noted in respect of IIA Sub-Centre Election 2023-2025

- 1. Nominee for the post of the OFFICE BEARERS/ EXECUTIVE COMMITTEE MEMBERS shall be Fellow/Associate Members of IIA
- Nominees for the post of Office Bearers shall have served as Member of the Executive Committee of the Sub-Centre at least for one full term of two years. (Attach Self Attested Copy of Proof)
- 3. A Self attested scanned copy of the Govt. issued Photo ID of the nominee shall be attached along with the Nomination Form.
- 4. Office Bearers shall not hold office for the same post for more than two consecutive terms.
- 5. Candidate, Proposer, Seconder shall have paid their subscription up to the year of 2024 2025 by 22<sup>nd</sup> May, 2023.
- 6. A member can contest for ONE POST only. If nominations from candidates are received for more than one post and not withdrawn for other posts by the due date, nomination/s of lower post/s will be cancelled and nomination for higher post shall be retained.
- 7. A co-opted member is eligible for election as an Office Bearer only if he/she has been co-opted in the FIRST executive committee meeting of the concerned Sub-Centre, and continued to serve for the full term of the concerned Executive committee
