

## SCRUTINEERS REPORT IIA ELECTION 2023-2025.

1. IIA Council announced the election for IIA for the term 2023-2025 on 27<sup>th</sup> April, 2023 and election scheduled was put on IIA Website on 29<sup>th</sup> April, 2023.
2. Nominations were invited from 15<sup>th</sup> May, 2023, Monday by 5.00 P.M.
3. Total 1637 nominations were received as per following details:-

3.1. National Council	: 172
3.2. State Chapters	: 687
3.3 . State Centres	: 628
3.4 . State Sub-Centres	: 150

- 4 Total 104 nominations were received beyond the scheduled time and were not considered.

5. There were 256 nominations which were rejected due to reasons listed below:

1. Nominations received after the announced date and time.
2. Incomplete Nominations sent with missing details.
3. Nominations sent without the ID Proof.
4. Nominations sent without the Proof of eligibility.
5. Nominations sent without the name of position e.g. President / Vice President, etc.
6. Nominations received with over-writing.
7. Nominations submitted have differences in the name of candidate, vis-à-vis IIA records or the ID Proof.
8. Nominations sent for Office Bearers position for more than TWO consecutive terms.
9. Dues are not paid by Candidate/ Proposer / Seconder as per the requirements.
10. Nominations sent for a Chapter / Centre / Sub-Centre other than the candidate's present place of affiliation or residence in IIA records/ID Proof.
11. Wrong Membership number is given by the Candidate / Proposer / Seconder.
12. Proposing or Seconding more than ONE candidate for any Office Bearer position.
13. Nominations sent without E-mail ID / Phone numbers.
14. Nomination form was sent by courier.
15. Nomination form was sent to iiapublication@gmail.com instead of iiaelections2023@gmail.com.

12. As scheduled, Election voting started on 27<sup>th</sup> June 2023 at 6.00 hrs. It was noticed that, there were some technical glitches at the server and it was decided to suspend the voting process at around 11.00 am on 27<sup>th</sup> June 2023, till further notice and a note to that effect was put on website. The technical glitches were resolved and it was decided to erase all the recorded votes from the system and restart the system at 8.00 pm on 27<sup>th</sup> June 2023 and extend the voting time to 9.00 am on 30<sup>th</sup> June 2023.

At 10.30 am on the 30<sup>th</sup> June 2023, the system was accessed by the scrutineers and the counting process of the ballots was done at IIA HO with the presence of candidates / representatives and also the process was relayed on facebook live for the benefit of the members.

The total count of votes where elections were held are attached in the form of printouts of each Ballot Paper.

After this process the results were downloaded, prints taken and put in a sealed cover and handed to the Jt. Hon. Secretary, Ar. Satish Mane and Ar. Ashutosh Agarwal.

13. As per Bye Law No. 4 / D / K, a list of candidates who have been elected in more than one position is listed below. The Council will take necessary follow up action in the matter.
