1. Submissions

Prospective authors are welcome to send the original and unpublished essays, interviews, articles (1500- 2500 words) and book reviews (600 and 750 words) in the areas of architecture, planning, urbanism, pedagogy, heritage, technology, ecology, theory and criticism, visual design, practice or any other relevant subject pertaining to the built environment for publication.

For a design project, please include the “Fact File” with the following details : Project Name, Location, Plot area, Total built up, Structural consultants, Project completion. For sketches and photo-essays, along with sketches and photo-essays, please send a 50-word write-up about yourself and a 200-words write-up regarding the sketches (please confirm that the sketches are all hand-done work by yourself.)

2. Length, style and format

The length of articles should be as follows:

- essays, interviews, articles (1500- 2500 words)
- book reviews (600 and 750 words)

The articles must be written in English. The language of the paper should be clear, concise and without unnecessary adjectives or repetitions. Unnecessary capitalizations should be avoided. It should only be used as is required grammatically at the start of sentences and for proper nouns. Do not use any bold

lettering except for titles and sub-titles. Italics may be used for sub-section titles (refer to the template) and for words in languages other than English. Please ensure that the meanings of these words is made clear in the text or stated within brackets.

Define abbreviations and acronyms the first time they are used in the text

UGC Regulations [Clause 9.3 of the recent Draft University Grants Commission (Minimum Standards and Procedures for Award of Ph.D. Degree) Regulations, 2022] for recognition of publications mentions that research papers published in 'refereed / peer-reviewed' journals are acceptable. JIIA is a refereed / peer-reviewed journal and it follows appropriate procedure for publication of refereed papers. JIIA has a team of editors, team of reviewers / referees and it also publishes regular monthly e-copy on the website of JIIA. 1. Submissions

It should only be used as is required grammatically at the start of sentences and proper nouns. Do not use any bold lettering except for titles and sub-titles. Italics may be used for sub-section titles (refer to the template) and for words in languages other than English. Please ensure that the meanings of these words is made clear in the text or stated within brackets.
- iii) Glossary of terms, especially for terms of a local language, etc. may be added at the end of the paper for the reader's understanding.

5. Procedure for Publication

The primary decision for inclusion will be made by the Editor of JIIA. If this is positive, the submission will then be sent to a suitable reviewer from the panel for comments, on a double-blind review basis. The decision from the Reviewers would be communicated to the author. The submitted papers may be accepted without revisions, or subject to revisions as suggested and re-refereeing before publication. Papers may be rejected on the basis of relevance or content.

In the first two cases, the author will be asked to make revisions, if necessary, and then re-submit. After final approval from the reviewers, the paper will be edited and proofread. The author may be contacted for editing advice in certain circumstances. This revised paper will be published after the necessary Copyright permission form has been signed and submitted. The format of the copyright permission will be sent to the author once the final paper is ready for publication.

Identify grants or other financial support, and its source, as was given for your research. Acknowledge colleagues or mentors who helped you to conduct your research or critiquing your manuscript. Do not acknowledge IIA or the reviewers and editors of JIIA.

Abstract

An abstract is a brief but comprehensive summary of the contents of the paper. It is an essential part of your paper which enables the reader to understand its subject. The abstract need to follow the same chronology of information as the main paper. Indicates what methodology you have used for your results and how you are concluding these results. Do not make any paragraphs here. Do not use any bold letters here. Use sentence case. Do not use unnecessary capitalization. No citations should be included in the abstract. Your abstract should range from 150 – 200 words. Use Calibri font, size 12, line Spacing: single.

Keywords : lower case, commas in between, 4-6 words.

Word Count (of main text below the keywords)

1. Introduction

1.1 Introduce the Problem with its Background

Presents the problem under the specific study of this paper and describes the research strategy. Do not label or title it. State the importance and implications of your study. IT is important that the gap in literature helps to perceive the importance of the sudy.

1.2 Aim and objectives

State the aim (research question), hypothesis (if any) and the objectives of your study in this order. Describe how these were derived from existing theories/ data and connect them logically. Explain how the research design permits the inferences needed to examine the hypothesis or provide estimates in answer to the question. State the scope and limitations of the study.

2. Literature Review

Discuss the relevant related literature here, but do not give a detailed account of all historical data. Instead, a scholarly interpretation of previous work on the topic should be summarized. This should include pertinent findings, relevant methodology and major conclusions. Citations and credits to pertinent works only should be stated.

3. Methodology

This section will describe how the study was conducted. Different kinds of studies will use different methodologies. A description of the methods you have used will help the reader to understand their appropriateness and the validity of the outcome.

It should elaborate the setting of the study, sampling strategy/ case study selection criteria; methods/ tools for data collection; documentation of data; data analysis framework.

2.1 Sub-sections

i) You may use sub-sections with titles in italics to give detailed information about the characteristics of the participants or subjects. Also give the criteria of inclusion or exclusion.

2.2 Other Subsections

Specify the research design and methods and measurement type used for each subject. Include the methods of data collection, whether by survey, questionnaires, case-study evaluation.

3. Results / Findings

In this section, summarize the collected data and the analysis performed. Describe the data in detail to justify your conclusions. Mention all the results, including contradictory ones. Do not repeat all the data in the tables or illustrations. Emphasize the most important ones first.

3.1 Analysis

Add in sub-sections for the various levels and steps of analysis, which lead to your findings.

4. Discussion

After stating the results, now evaluate and interpret the implications with respect to your aim/ hypotheses. Here, you can examine the results and draw inferences and conclusions. Emphasize any theoretical or practical consequences of the results.

Begin the Discussion section with a clear statement for your aim/ hypotheses and link the conclusions to these. Do not simply reformulate and repeat points already made. End the Discussion section with the importance of your findings. You may state the importance of the problem/ question (as stated in the introduction). Discuss your findings in the light of the literature review, highlighting the original contribution. Corroborations or contradictions with earlier studies, if any, may be mentioned.

(In case the Discussion is brief, you may combine it with the Results section and call it Results and Discussion.)

5. Conclusion & Recommendations

Write the practical significance of the outcomes, what real-life phenomena might be explained by the results. What are the problems that may remain unresolved or may arise from your findings. One or two such areas of further research may be mentioned.
