Important notes in respect of IIA Chapters Elections 2026-2028

1. For the post of Chairperson and Vice Chairperson, the nominees must be Fellow Members of the Institute and must have served at least one full term as an Office Bearer of concerned Chapter and shall submit self-attested documentary proof of having served as such along with his nomination.
2. For the posts of Hon. Treasurer, Jt. Hon. Secretaries, the nominees must have served at least one full term as an executive committee member of the concerned Chapter and shall submit self-attested documentary proof of having served as such along with his nomination
3. For the other posts, the nominee shall be a Fellow or Associate Member of the Institute.
4. No Office Bearer shall hold the **same office for more than two consecutive terms**.
5. The nominee shall submit a copy of their Government-issued Aadhaar Card and PAN Card along with the nomination. If elected these documents may be used for banking and other official purposes wherever required.
6. The **Candidate, Proposer and Seconder** shall have paid their subscriptions as One time payment or up to Financial Year 2028 on or before the last date of receipt of nomination i.e. by 17.00 hrs on 20th July, 2026.
7. In the event a member files nominations for more than one post and fails to withdraw the additional nomination(s) within the prescribed time, only the nomination for the **higher office** shall be retained, and the nomination(s) for the lower office(s) shall stand cancelled.
8. A co-opted member shall not be eligible to contest for the post of Office Bearer.
9. The duly completed and signed Nomination Form, together with all required annexures and supporting documents, shall be scanned and submitted by e-mail to **iiaelections2026.28@gmail.com** on or before the date and time specified in the Election Schedule i.e. 17.00 hrs on 20th July, 2026.
10. For any matter not mentioned above, the decision of the Scrutineers shall be final and binding.
